CREATE A LEGACY BY GIVING TO THE SCHOLARSHIP AND LOAN FUND

Financial support of the Scholarship and Student Loan Fund includes gifts made as memorials to family and friends, as well as planned giving through trusts and estates. The Rod Parsch Memorial and the Joann Nelson Memorial Scholarships are given annually at our high school honors convocations; the donors and memorials are published in the program at each school.

The scholarships and loans have been distributed to college students who graduated from Lapeer High School, Lapeer West, Lapeer East and Lapeer Community High Schools.

The Lapeer Community Scholarships were established with donations from Lapeer teachers, staff and community members. Some made one-time, others made payroll deduction donations. Five-\$1,000 Community Scholarships are given to students from all three high schools. The selection criteria includes attending Lapeer Community Schools for at least seven years.

HISTORICALLY SPEAKING...

The Lapeer High School Student Loan Fund wrote its first loan in 1924. A scholarship program was later added. IN THE PAST 10 YEARS

Over 200 Loans have been distributed in the amount of over \$300,000.

Over \$100,000.00 in scholarship money was distributed.



In 2012, 23 loans were issued to Lapeer graduates students through this fund assisting them with their college expenses.

College graduates are making regular payments back to the Fund which will in turn be used as new loans for next year's high school graduates.

In 2012, Lapeer graduates received \$9,300 in scholarships.
